**RE: EBOTSE BOARD NOTE 9: COVID -19, MORE GUIDANCE & CLARITY ON LEVEL 4 REGULATIONS, APPLICABLE ON EBOTSE**

Dear Residents

The detailed regulations pertaining to personal movement as conveyed in Board Note 6 refers.

First and foremost, we thought it is important that we convey the over arching regulations which will remain in place (until further notice) after the national lockdown, regardless of the level of alert at any given time:

- Sit-in restaurants and hotels.
- Bars and shebeens.
- Conference and convention centres.
- Entertainment venues, including cinemas, theatres, and concerts.
- Sporting events.
- Religious, cultural and social gatherings.
- No gatherings of more than 10 people outside of a workplace environment will be permitted.
- Passengers on all modes of transport must wear a cloth face mask to be allowed entry into a vehicle.
- Hand sanitisers must be made available, and all passengers must sanitise hands before entry.
- All public transport vehicles must be sanitised on a daily basis.

Below is some clarification on some of the “personal movement” regulations applicable on Ebotse, as communicated in Board Note 6:

### Exercising on the Golf Course

Please take note that the Board due to the time limit restriction on exercising allowed only between 06:00-09:00, granted access to the golf course area, subject to the following important rules:

- The community may exercise, run and walk on the golf course **fairways**. No exercising, walking, running or kiddies playing will be **allowed** on the **greens, tees and bunkers**.

- Under no circumstances will **bicycles** be allowed on any part on the golf course, with the **exception of the concrete pathway** around the 16<sup>th</sup> and 17<sup>th</sup> golf holes, connecting Phase 1 with the western side of the Estate over the wooden golf bridge.
- Please people, this causes major damage to a very important asset that must be maintained, and will we issue hefty fines in this respect.

**Meetings will be Limited to a Maximum of 10 People**

Please take note as conveyed above, that no **gatherings or meetings** of people more than 10 people will be permitted outside of a **work environment**.

To make things clear, this rule as enforced by COGTA, is binding on us as a HOA and to you as a member of public to adhere to in a working or business environment. We made it clear, as communicated in Board Note 6, as referenced in SA Government Gazette, No. G43258, dated 29 April, Chapter 3, Paragraph 16, that no **recreational travel or meeting of friends and family** will be permitted under Level 4 restrictions on Ebotse.

Lastly, we want to wish all our mothers a “Happy Mother’s Day” this coming Sunday, may you all, who are special and treasured in our lives, be spoiled silly on Sunday. 

We will keep the community posted on any change in regulations.
